

LRC Board of Directors Election Process – Questions & Answers

1. Who may be considered for nomination to the LRC Board of Directors?

Any LRC member in good standing who has been a member of the Club for at least three (3) years is eligible for nomination. Current Directors whose terms expire at the end of 2026 may also be considered.

2. Does expressing interest guarantee a nomination?

No. Expressing interest and submitting a bio allows the Nominating Committee to consider a member for nomination, but it does not guarantee placement on the final slate of candidates.

3. Are current Directors automatically renominated?

No. Directors whose terms are expiring are not automatically renominated. All potential candidates—current Directors and eligible members—are reviewed by the Nominating Committee.

4. How many Directors will be nominated in 2026?

As part of the Club's planned Board reduction, four (4) Directors will be nominated for election at the 2026 Annual Meeting.

5. What is the length of a Director's term?

A Director serves a three-year term beginning January 1 following the election.

6. What are the expectations of an LRC Director?

Serving as a Director involves more than attending Board meetings. Directors are expected to:

- Actively participate in Club governance and decision-making
 - Serve on committees or support Club initiatives
 - Contribute time and resources to advance the Club's mission
 - Work collaboratively and in the best interest of the LRC

7. I have never served on the Board before. Should I still apply?

Yes. The Nominating Committee welcomes interest from members with diverse experiences and perspectives. Members who have not previously served on the Board are encouraged to express interest and learn more about the role.

8. How do I express interest in being considered?

Members should contact the Nominating Committee Chair to request a Candidate Packet, which includes a standardized bio template.

9. What is the deadline for submitting my bio?

Completed bios must be emailed to the Nominating Committee Chair no later than **April 15, 2026**, to be considered.

10. What happens after I submit my bio?

Each bio will be acknowledged by email. The Nominating Committee will review all submissions and prepare a recommended slate of candidates, which will be submitted to the LRC, Inc. Secretary no later than **June 15, 2026**, in accordance with the LRC By-Laws.

12. What if I miss the April 15th deadline, what can I do to be considered?

Additional nominations of eligible Club members for positions on the Board of Directors may be made by written petition addressed to the Secretary and received on or before September 1, signed by 100 members or 10% of the membership, whichever is greater and accompanied by the written acceptance of each such additional nominee signifying willingness to be a candidate. Nominations by petition shall comply with the requirements for geographical representation on the Board as set forth in the provisions of Article III, Section 2.
